Title Mr. Chilcoat reiterated we still have growth to make; however, we’ve learned some things that are making a positive impact. We are at 84% (B+) for state school report card status. Other good news: district gave the go-ahead to hire another 1st Grade teacher - to reduce class size. BYU student teachers completing Fall assignments - we are optimistic and will be very intentional for success as we move forward.
